## **Bob Mason**



Bob had experienced kidney problems over the past couple of years and succumbed to the disease on the 10th August 2018. A funeral service for Bob was held at the Port Macquarie Crematorium on the 15<sup>th</sup> August 2018.

Bob commenced in the Postmaster General Department (PMG) as a Technician in Training (TIT) in 1946, a boy from Gloucester. Where he returned on completion of his training. Whilst there he visited schools in the district and extolled the availability of a technical career path for students in the PMG. Bob recruited our own Peter Hack at the Gloucester High School in 1956.

After about five years, Bob married Elaine and they moved to Elanora Heights and then Narrabeen. Bob had an interest in social affairs, people's welfare and politics. He was on the Branch Council of the PTTA (later the ATEA) in the 1960s. He was also a member of the ALP and was extremely proud when he was made a Life Member.

During his career in Sydney Bob worked on installation and maintenance in the Eastern Suburbs and the Sydney CBD. Working in the City allowed Bob to follow up his investment interests on a daily basis and he formed some very strong friendships at the stock exchange.

He still visited the stock exchange, on a daily basis after he retired and on Thursdays, about noon he would join us at the Catholic/Castlereagh Club for a few social drinks.

He enjoyed making home brews of beer and red wine, and of an evening would settle back and listen to classical music. His favourite composer Gustav Mahler and conductors, Georg Solti and Leonard Bernstein.

Bob and Elaine moved to Lake Cathie about ten years ago and settled into a nice friendly welcoming community.

Many family and friends and workmates attended Bob's funeral.

### 67 is the New 70

The past month has seen a change of prime minister in Canberra. For Mr Turnbull, triggered by an energy policy. The same policy issue that seen him lose leadership before. I suspect it was more than energy policy that brought about the leadership change. I will spare you any further discussion on the leadership change. Except to comment on two outcomes for seniors and pensioners.

First, the government has dropped its plan to withdraw the energy supplement payment for pensioners. Since the disastrous 2014 budget, the abolition of the energy supplement has been government policy. The second outcome was the abandonment of a plan for the gradual increase the retirement age to 70 before a person could receive a pension. This would have given Australia the highest retirement age among developed nations. This was another policy introduced in the 2014 federal budget. Mr Hockey, then treasurer preceded the announcement of this measure in his 2014 budget speech with the words "the age of entitlement is over".

It is remarkable how a government can abandon their long-held policies and principles when they perceive they need to win favour with the electorate.

## Outsourcing

I read that Centrelink has outsourced its call centre to a private company called Serco.

Serco is a British based organisation known in Australia for its association with offshore detention. The company has roots in many countries. It offers privatised services to immigration detention centres, prisons, defence assets and welfare. Serco will accept anything on offer.

Also, NDIA (National Disability Insurance Agency) has taken on inexperienced labour hire staff.

The current government in 2014, placed a staffing cap limit of 3000 people in the NDIA.

The NDIA will need 7000 positions as the NDIA approaches full rollout. NDIA will have no option other than to outsource and rely on contract staff because of this arbitrary staff cap. The NDIA has a budget of \$8 billion dollars this financial year. The budget will be \$22 billion dollars in 2021-22 when fully rolled out.

Both disability advocates and the Productivity Commission said the staff cap will lead to poor outcomes. Especially, in the early stage, when the agency is building capacity and institutional knowledge and developing first plans for many participants.

Another example is the federal government decision to award a \$444 million dollar grant to a NGO, the Great Barrier Reef Foundation. The decision was taken without a public tender or reference to its Federal Environment Department. A Senate Inquiry has found the Great Barrier Reef Foundation did not table a plan for the barrier reef or indeed seek a grant from the government. The agency currently has about ten employees. Government departments such as the CSIRO and Reef Marine Park will need to make applications to the Foundation for any of their initiatives to save the save the reef.

Despite public scepticism when it comes to privatisation and outsourcing, governments have pushed-on. It seems the Public Service is being privatised by stealth.

## A Message from the President (cont'd)

The theory is that the private sector is always more efficient (read cheaper) than the Public Service. The public realises that outsourcing has delivered no actual savings, indeed the opposite might be the case.

Britain realised it had a massive problem when a private company Carillion collapsed. The company held about 450 British Government contracts. This left a totally deskilled Public Service to try to sort out the mess. A mess that encompassed provision of school meals, hospital beds, military accommodation, library services, prisons and railways. It also left tens of thousands of employees and sub-contractors out of work.

Fortunately, here in Australia, there is a current Senate inquiry into the use of outside "experts". Labor MP Julian Hill is deputy chair of parliament's committee of public accounts and audit. Mr Hill maintains that the notion that the private sector can do a better job cheaper is a myth. He offers the example of the Bureau of Statistics and the 2016 census disaster. The bureau admitted that the cost of a labour-hire contractor to do the IT work was 200 per cent more than employing a person as a public servant.

Nadine Flood, National Secretary of the CPSU (Community and Public Sector Union) claims the outsourcing in Centrelink was a result of an earlier government decision. The government had reduced Centrelink staff numbers in the hope that people would use the Internet for their claims and inquires. However, this proved not to be the case.

The Public Service is there to give honest and accurate advice to both the public and the Government. This allows governments to make correct decisions. Privatisation has done away with a wealth of knowledge. It has not proved to be cheaper and has thrown many hard-working public servants out of work.

Well, I think have said enough. I look forward to seeing you at our next general meeting.
