### Welcome to your March 2020 Newsletter (cont'd)

#### **The Cost of Bushfires**

I came across an article in The Lamp (the New South Wales Nurses and Midwives Association magazine). The article provided a timely reminder of the cost of not attending to climate change.

The article states that over 10 million hectares were burnt, 28 people killed, around 2,000 homes destroyed. During the bushfires, hazardous smoke covered Sydney, Melbourne and Canberra. In early January the Insurance Council of Australia estimated the damage bill at \$700 million, this will go well beyond this figure as it makes further damage assessments.

Wildlife experts estimate over a billion animals lost their lives in New South Wales alone.

The fires have created risks to several factors critical to human survival, wreaking havoc on pollinators and posed risks to water supplies and infrastructure

The Lancet estimated the direct human costs, alone, of major bushfires in the period 1967-2013 was \$4.7 billion due to 433 direct fatalities and over 8000 injuries.

The US Environmental Protection Agency puts the indirect effects of air pollution from bushfires, premature death and morbidity, in the USA during 2008-12, at an estimated cost of \$US 513 billion.

Experts, our Fire Chiefs, agree that hazard reduction can assist in bushfire control in the immediate term, but the major requirement for a safer long-term future for our children and grandchildren needs immediate action on climate change.

#### **Sports Rort Affair**

Meanwhile, the so called "sports rorts" affair continues in Canberra. The role and intervention of the Prime Minister is coming under more focus. Various sports committees throughout the country made submissions for their sports projects to the government agency Sports Australia. The agency job was to review the projects and rate their entitlement for a grant. It is now clear, the then Sports Minister ignored the Sports Australia recommendations and instead indulged in pork-barrelling just prior to the federal election. A majority of Sports Australia's recommendations were overturned.

Hence the infamous spreadsheet showing the various project submissions coloured coded based on whether the submission came from marginal or a safe Coalition or Labour held seat.

Latest news is that the project approvals where altered during the election period when the coalition government was in caretaker mode meaning no government business until the election outcome is known. Then Sports Minister Bridget McKenzie denies she made these changes. We know there were over 140 emails exchanged between the Sports Minister and Prime Minister offices. Who then altered the grants outcomes?

Prime Minister Morrison has declined to take questions on the sports grants at a recent press conference.

The Sports Rorts affair has overshadowed other potential grants scandals. Take, for example, the \$500 million Commuter Car Park Fund announced in last year's April federal budget finance suburban commuter road to rail development.

First note, the federal Infrastructure Department confirmed there are no public guidelines or eligibility criteria for selecting the car park projects.

Victoria received the bulk of the funds; thirty projects in Melbourne. The Car Park Fund approved several stations in Treasurer Frydenberg's seat of Kooyong where he faced a strong challenge from the Greens and a high profile independent. Liberal seat of Goldstein had a station approved for Brighton Beach, a high-income area. The Victorian Government claims there was no consultation before the projects' announcements.

Compare these approvals to the Victoria's areas of highest population growth; the low-income western suburbs, serviced by 40 train stations. They received no funding.

Back in March 2019, I wrote about the case for a Federal Anti-Corruption Commission. I mentioned that opinion polls continue to show that the public holds our politicians in very low regard. They serve their own personal interests rather than the electorate at large. One year later, politicians without judicial oversight (Federal ICAC) are becoming more blatant and bold in their quest to retain their seats in parliament.

### \$250 Regional Seniors Travel Card

The regional seniors travel card provides eligible seniors living in regional, rural and remote areas of NSW with a \$250 prepaid card to help ease the cost of travel. You can use the card at certain retailers to pay for:

- pre-booked NSW TrainLink Regional trains and coaches,
- fuel
- and taxis.

The travel card is valid for 14 months from the date the card is issued. The expiry date is available on the front of the card. The regional seniors travel card program is available for a 2-year trial period (2020-2021).

Eligibility for the trial, you must be:

- receiving the Age Pension (you must have received the Age Pension for at least one month); or
- a Commonwealth Seniors Health Card holder (you must have held your card for at least one month); and
- living outside of Sydney, Newcastle and Wollongong.

The trial will be expanded in the coming months to include more seniors receiving pensions from the Department of Veterans' Affairs. You will be eligible if you are:

- aged over 66 years
- you reside outside of Sydney, Newcastle and Wollongong
- you receive one of the following pensions:
- Service Pension
- Disability Pension under the Veterans' Entitlements Act 1986
- War Widow(er) Pension





Despite the song, you will be able to get a cold beer if you like! 
#### Day 6
