

## VALE JOHN HICKEY

John Lane



**The Retired Members Association is sad to report to members that John Hickey passed away on the 1<sup>st</sup> November 2020 at the age of 93. John was a member of our Association for over twenty-four years.**

**John was on our committee for twelve years and regular attendee at our General Meetings.**

**President John Lane has the following tribute to his friend and fellow member of our Association. There is a further tribute to John Hickey on page 3 of this newsletter.**

I first met John in 1977 when I moved to a section where John had an office in the Sydney CBD. Although we never worked directly together, we became close friends. I'd like to think this was because we shared the same social beliefs and ideals.

I remember a time when John was doing a Bachelor of Arts Degree when he was in his mid-fifties. He called me into his office one day and asked me to read this paper he had written as part of his degree. He wanted my opinion. The paper was about the history of our Australian health system, and John had covered everything in much detail.

After reading the paper, I said, *"Wow! you have put a lot of research into this"*, to which he replied, *"I haven't actually, nearly all of it came from personal knowledge, and that is why I am seeking your opinion"*. I believe it speaks volumes about where his interests lay.

John was a most principled man. The best demonstration of his principles was when our Union, the ATEA, was in the middle of a major industrial dispute in 1978; the ARE11 dispute. Senior management had issued an instruction to all middle managers to go to their staff members and direct them to carry out a spurious task in a foreign telephone exchange. Technicians would refuse to carry out these instructions and were stood down. To my knowledge, John was the only manager who refused the upper management's instruction to take part. He was a member of the Union and

was going to adhere to the Union line. John came to me to tell me he was going to resign from the job as he felt his career would be now be over; he was not expecting very favourable treatment from senior management in the future. I was Vice President of the ATEA (Australian Telecommunications Employees Association) at the time; myself, along with help from Ken Walton, talked John out of this action.

Once there was a dispute resolution, no reprisals followed; in fact, John received a significant promotion before he retired. It speaks volumes of the respect that senior management had for John. He also had the respect of his staff.

John spoke so much about his life in Condobolin (Condo), where he was the OIC for several years; it was as if that was where his PMG life began from my perspective. I could establish that after John finished his training; he was a technician on shifts at Homebush Exchange. Later, he went to Barmedman as a senior technician and then the OIC position at Condobolin.

I understand that John wanted to return to the big smoke to raise his family. He did this by obtaining a transfer to the position of Shift Leader at City North Exchange. Later, he had a promotions to the OIC positions at Rose Bay, Pitt Exchange, and then the Customer Installation Manager for the North of the City. His last appointment was Manager, PABX installation NSW.


I remember attending John's retirement function. I only caught up with him on occasions after his retirement. Later, after my retirement, I joined the *Retired Members Association* and found John on the committee.

We would have lunch together on regular occasions after a committee or general meeting. I became part of the "**four Johnnies red wine club**" because invariably, this became our drink of choice along with John Bryce and John McAuliffe.

I was also privileged to meet John's wife Kath on several occasions, and I feel fortunate to have been able to give her my sincere condolences to her in person.

I would like to take the opportunity to acknowledge and thank Peter Hack on behalf of our Association. Peter remained in contact and visited John and wife Kath when they were in care. He was a great comfort to them and kept us updated on John and Kath's health. In fact, the last time I spoke to John on the phone he spoke of the admiration he held for Peter on more than one occasion.

So many of us will miss a dear friend of such a great principle.

## John Hickey



John Hickey, a member of our Association for over twenty-four years and a friend to us all passed away on the 1st November 2020. There was a funeral service for John on the 6th November 2020 at Saint Vincent's Catholic Parish, Ashfield. He was 93 years of age.

John was the third born child and had four sisters. John grew up in a happy family devoted to their Catholic faith. However, it was a time of great hardship because of the Great Depression. Within his street, John's father was the only person with employment; just one day a week.

After John completed his school education, he joined the PMG as a Technician in Training. His career in the PMG, Telecom and Telstra was to become long and successful one. He finished his career as senior manager. He had a reputation as an excellent people manager.

John married his wife Kath when they were both twenty years of age. They raised four children Geoff, Margaret, Trish, and John. After qualifying as a senior technician, the family moved from the city to the country. First, John went to Barmedman and then to Condobolin, where

John was the OIC for eight years.

John and Kath returned to the city and lived at Lidcombe. Later in 1980, they moved to Lapstone to be closer to their family. It was a happy time for the family; John and Kath had ten grandchildren, eleven great-grandchildren and two great-great-grandchildren. It was during this time John took early retirement. John and Kath moved to Ashfield in 1996.

John valued education; he ensured all his children had an excellent education. John himself achieved a university degree at fifty. John worked as a volunteer for several charitable institutions, including Vision Australia.

The Association presented John with a "Certificate of Appreciation" in November 2014. John had served on the committee for twelve years. It is thanks to the effort of members like John Hickey; our Association grew into the organisation it is today.

# THE YEAR 2020: A YEAR WE WOULD ALL LIKE TO PUT BEHIND US.

## COVID-19

The year 2020 is a year we would all like to put behind us. The year started with disastrous bushfires and followed shortly after that with the COVID-19 pandemic. Fortunately, in Australia, the State governments' priority was the community's health and welfare. The governments listened to the health experts' advice.

Sadly, other countries have not been as fortunate. Their governments were less inclined to heed the advice of their health experts and timid in their response, fearing the economic consequences of a general population lockdown. Of course, not that there has been no impact of the pandemic in Australia. We have had over 28,000 infections and 900 deaths; most of the deaths have been in aged care homes. The USA, UK and other countries exceed our total death toll each day.

As we move into 2021, our country will rely on testing and tracing, and the welcomed news there will be the general distribution of a vaccine.

As the pandemic comes under control, the focus will shift to economic recovery and people's return to employment. Here, we are not likely to see the same level of bipartisanship dealing with economic recovery. Now the federal government is turning back to their old ideology of having a balanced budget. The government is being encouraged by the latest quarter's GDP growth and unemployment figures. However, the country is still worse off than at the pandemic's commencement and the resultant lockdowns.

The *JobKeeper* programme ceases in March and the financial supplement for *JobSeeker* will also end in the same month. Many sectors of the economy will continue to suffer well beyond this year. If the Great Depression taught us anything, reducing incomes, like age pensions, welfare payments and wages would only prolong and deepen the current recession. The government is now proposing broad changes to industrial relations, replicating the disastrous "work-choices" legislation.

Our economy has spluttered along since the global financial crisis of 2008. Early removal of income supplements will not be suitable for the unemployed or the economy. It comes back to need to have money circulating quickly throughout the economy. Asking the workforce to do the heaviest lifting,

reducing incomes, and work conditions is not the answer. Instead, there is the need to invest in infrastructure and direct support for ailing parts of the economy.

## Royal Commission Recommendations

Our newsletter featured many articles focusing on the Australian Banking Industry's corruption and the need for its reform. Many Australians lost their homes and life savings, and farmers lost their properties. The bank's insurance arms failed to pay out on policies based on the flimsiest of excuses.

The Federal Government, for a long time, ignored repeated calls to have a Royal Commission. When Treasurer, Mr Morrison even chastised the Labor Opposition for their repeated calls for a Royal Commission into the financial services industries. He claimed the Labor Party calls for a Royal Commission were irresponsible, as they would undermine Australians' confidence in their banks and other financial services. He ignored the fact that Australians watched and read reports of unscrupulous behaviour on the part of the banks and their subsidiary insurance companies each day. The multitude of bank scandals was even aiding organised crime. Some banks were facing billion-dollar fines.

Facing an upcoming election calls for a Royal Commission had become too loud for the federal government to continue to ignore.

The Royal Commission had limited terms of reference and a short timeframe for hearings and their report's delivery. The Royal Commission delivered their final report to the Governor-General on Friday, 1st February 2019. The final report showed that the financial services industry disobeyed the law and regulators had not enforced the law effectively.

Amid the pandemic, Mr Frydenberg granted the banks an extension into this year for the banks and other financial services to respond to the Royal Commission's reform recommendations. Mr Frydenberg is trying to tell us that the financial services industries (the big banks) could not cope under these extraordinary pandemic circumstances, despite their vast resources. In contrast, average Australians had to adapt to life-changing circumstances, months of lockdown, working from home, reduced incomes and having to school tutor their children for good measure.

## THE YEAR 2020: A YEAR WE WOULD ALL LIKE TO PUT BEHIND US. (CONT'D)

The Australian public adapted to new conditions, months of lockdown, working from home, reduced incomes and having to school tutor their children for good measure. Meanwhile, the financial services industries who had been ripping them off for years received a free pass.

*The Guardian* newspaper reported on Tuesday, 19<sup>th</sup> January 2021 that close on two years after receiving the Royal Commission's recommendations, the government has either abandoned or not fully implemented more than half of the recommendations. Mr Frydenberg has undermined the pro-regulation consensus that was evident after the Royal Commission announced its recommendations. Now, he is taking advantage COVID-19, telling us the implementation delays are because of the pandemic environment

**Not content with stalling the Royal Commission's recommendations, the Treasurer has introduced new laws that are the reverse the Royal Commission's recommendations. He describes the new laws as removing "unnecessary barriers to the flow of credit to households and small businesses". The changes will allow retailers to continue to sell loans to customers at the point of sale. The Royal Commission recommended that this practice should discontinue. The government had previously announced the Royal Commission's recommendation would be in place by the end of 2020.**

The Treasurer has also rejected the Royal Commission's recommendations, banning mortgage brokers from receiving commissions over a home loan's life and they receive the same treatment as financial advisers. Again, the lobbyists were soon at work after the announcement of this recommendation. They portrayed the mortgage broker as small business owners who were just serving the interests of home borrowers.

**All this is a far cry from two years ago when Mr Frydenberg appeared before the cameras. Then he promised swift action to implement the Royal Commission's recommendations, promising this would take just months to complete. Like many times before, the banks have employed lobbyists to influence the federal government successfully. Doing so, once again, they have drowned out the voices of ordinary people.**
